Abstract

Rabindranath Tagore-the Indian grande-preneur-wrote a lot of his poems about nature as well as its environs. It is unclear, however how many of his poems explicitly focus on the issue of eco-criticism. Literary ecology was the original idea that developed into eco-criticism. Ecocriticism is a term which refers to the study of interaction between literature and nature. Tagore often criticized the beauty of nature in his poems. He has depicted magnificent scenes of landscapes, rivers, forests, and mountains while going into the details of flora and fauna of the countryside. The present study aims to look into how eco-criticism is incorporated and how important it is in some of the works by the renowned Indian author Rabindranath Tagore. Tagore also focused the ultimate emphasis on the people's coexistence with nature. It is an important addition to the literature canon in terms of using eco-criticism in poetry, and his writings never failed to prompt readers to respect and preserve the environment.

This collection of poems from Tagore reflects several aspects in nature, as well as how man goes about relating to it. The "Stream of Life" describes how everything in life is connected. "Light, My Light" discusses just how beautiful nature is. Other prominent works of Tagore, which are related to environmentalism, include "The Gardener," "The Sunset of the Century," and "The Last Bargain." Whether these can be considered or not in the category of ecological criticism literature is subjective because with Tagore's great references to nature, it is a difficult task to mark just how many poems fall under this label of eco-critical poetry.

Rabindranath Tagore was one of the best writers and poet, and writer and philosopher from India who cared immensely for the environment and the ecological problem. Tagore also wrote extensively about how industrialization affects the environment. In "The Home and the World," he writes about the detrimental effects of British colonialism and industrialization on rural India. He provides examples of how the emergence of new businesses and technology led to pollution, deforestation, and the elimination of conventional farming practices.

In another composition, "The Post Office," Tagore gives an example of human interaction with the environment. In the play, a small child confined to his house because he's sick takes comfort in a bird that is outside the window. The play warns against destruction of nature and dwells on how important it is for humans to be comforted and inspired by it.

"Dakghar" or "The Post Office" is written in 1912 and applauded as a presentation of eco-criticism reflecting the themes of death and the relationship with nature. The play was set in a small Bengali village showing the real beauty lies in nature. Amal, the young hero who is bedridden because of illness, is longing for the outside world. His love for nature and her wonders increases by the imagination and letters of the

postman. The play comes out as a film and as a television series, and it remains to be one among the great classics of Bengali literature.

"Ghare-Baire" is published in 1916 in Bengali language by Tagore and eco-criticism is discussed from the perspective of western culture and its impact on Indian society that affects the Indian ethos of people, The novel further discusses the colonialism and economy which is influenced by the same. The novel stresses on the environment to be safe so that coming generations will be more comfortable in residing.

Questions of the natural world are engaged in many books by Tagore, including such as "The Home and the World," "Gora," and "The Wreck." For example, Bimala in "The Home and the World" is attracted by natural beauty surrounding her home, and love to nature contrasts with an urban world of industry threatening the same. Like this, Gora, protagonist of the novel "Gora," also deserts his urban advanced life for a more natural and rural one.

Even Tagore suggests a degree of vulnerability as far as human activity is concerned in relation to the environment. Tagore grieves his losses and ecological damages when he narrates the calamity the wreck of a ship brings in The Wreck". A lot of emphasis to strong expression of ecological sensitivity too appears through promotion of interdependence and how crucial it becomes to keep making sure they preserve a wholesome relationship with nature.
