### 2.1 Material

- **Fabric:** Medium-weight fabrics like cotton.

- **Interfacing:** Lightweight fusible interfacing may be used to reinforce the collar and cuffs.



- **Thread:** A thread that matches the fabric in colour. Cotton or polyester threads.
- **Buttons:** Buttons that complement the shirt fabric will be needed for the front closure and cuffs.
- **Leaf printing:** Green and Brown felt or similar fabric scraps, can be used for the leaf designs.

- **Sewing Tools:** Scissors or rotary cutter Pins, Needles (hand or machine) Measuring tape, Iron and ironing board, Sewing machine.

## 2.2 Methods:

- **Cutting:**

Lay out the fabric and pattern pieces according to the pattern instructions. Pin the pattern pieces to the fabric and cut them out carefully. Transfer any markings from the pattern to the fabric.

- **Sewing:**

Sew the shoulder seams together. Attach the collar to the neckline, using interfacing for reinforcement if needed. Set in the sleeves. Sew the side seams and underarm seams in one continuous seam. Hem the bottom edge of the shirt and the sleeve cuffs.

- **Finishing:**

Add buttonholes and sew on the buttons. Press all seams and edges for a clean finish.

- **Printing:**

Cut out the leaf shapes from the green and Brown felt. Position the leaves on the shirt front and pin them in place. Use a colours the leaves securely to the shirt.

- **Finishing & Fittings:** Give the shirt a final press to remove any wrinkle.
