It promotes the diversity, inclusivity, and the notion that reality is constructed through language, culture and power. Theorist like Jean Lyotard, Roland Barthes, Micheal Foucault, Jacques Derrida and Jean Baudrillard played a major role in defining the elements of postmodern theory.

Feminism

Feminism as a movement started in the 19th century to fight against gender based inequalities. Feminism in literature refers to the representation, exploration and experiences of women in the literary works which reflects the practical world. It examines the historical significance of role of women in society and how they faced the challenges. It also highlights the gender stereotypes and women's voices and perspectives, and fights for equality. Before 19th century women were marginalized and considered secondary. Elaine Showalter, an American critic who became famous for her concept of gynocriticism, broke down the 'female literary tradition' through three phases. The first phase as "feminine" is about imitation of dominant traditions and female writers using pseudonyms to publish their works. The second phase as "feminist" where women protested against inequalities and the third phase as "female" where women became self-aware.

Postmodern feminism calls attention to diversity, inclusivity and encourages multiple voices and perspectives from different race, class and sexuality. Luce Irigary, a French feminist and cultural theorist states that language pattern is gendered where the dominance of men and subjectivity of women is showcased. she encourages acknowledging the sexual differences and allow women to represent themselves to create their own identity. Judith Butler, an American philosopher states that "gender is performative" which means gender is not static but keeps changing over time based the circumstances. Butler asserts that power shapes our perception of gender and urges feminist to stop defining 'women' and focus on the power structure. Helen Cixous, a French Writer explored the sexual differences. She reinterpreted myths and analysed the portrayal of women.
