This paper examines how Kane reconstructs Menaka's story to explore human experience while challenging patriarchal interpretations of mythology. Moving beyond Menaka's conventional portrayal as a celestial temptress, the novel presents her as a woman seeking love, belonging, dignity and self-determination. Through thematic analysis of domestic life, feminism, empowerment, etc., The study shows how these themes shape Menaka's journey from divine servitude to self-realization. It argues that Kane humanizes mythological characters by emphasizing emotional vulnerability, ethical conflict and psychological growth, making mythology relevant to contemporary society. Characters such as Uruvi, Urmila, Surpanakha, Ahalya, Satyavati and Menaka are no longer confined to supporting roles but emerge as protagonists with agency and psychological depth. By allowing these women to narrate their own experiences, Kane challenges patriarchal interpretations and transforms mythology into a space for examining identity, freedom, dignity, justice and empowerment.

In classical mythology, Menaka is primarily remembered as the celestial apsara who distracts the sage Vishwamitra at Indra's command, while her emotional world remains unexplored. Kane reconstructs her as a woman capable of love, compassion, courage and independent thought, transforming her from a passive instrument of divine authority into an autonomous individual seeking emotional fulfillment and self-determination. “The portrayal of suppressed women as a protagonist is the common strategy of postmodern fiction. The novel *Menaka's choice* presents the fictitious character Menaka as a real woman of flesh and blood” (M and A 1710) Through Menaka's journey, Kane explores the emotional consequences of patriarchal authority, institutional control and social expectations while presenting feminism as the pursuit of dignity, equality, resilience and meaningful choice rather than opposition to tradition.

Kavita Kane's contribution to Indian English literature extends beyond the retelling of myths. By integrating timeless mythology with contemporary social realities, she demonstrates that mythological fiction can preserve cultural heritage while addressing universal questions of identity, gender, freedom and human experience. The condition of womenfolk is always pathetic, it could be related to contemporary society" (M and A 1710). Love becomes a transformative force that enables Menaka to experience companionship, belonging and self-discovery,

while sacrifice reflects responsibility, compassion and moral conviction rather than passive submission. By integrating the themes of empowerment, human nature, society, life, love and sacrifice, Kane transforms mythology into an exploration of the universal human condition.
