



Razakars' Violence in Hyderabad State: A Socio-Political Analysis of Conflict, Power, and Integration (1946–1948)

Abstract

The period between 1946 and 1948 in Hyderabad State witnessed intense socio-political turmoil marked by the rise of the Razakar militia and widespread violence across rural and urban regions. Organized under the leadership of the Majlis-e-Ittehadul Muslimeen, the Razakars emerged as a paramilitary force supporting the Nizam's resistance to integration into the Indian Union. This paper examines the nature, causes, and consequences of Razakar violence within the broader context of Hyderabad's political crisis. It analyzes how feudal structures, communal tensions, and political uncertainty contributed to the escalation of violence, particularly against peasants, political activists, and marginalized communities. Drawing upon archival records, contemporary newspapers, memoirs, and scholarly studies, the research explores the role of Razakar militancy in shaping public opinion and accelerating the Indian government's decision to intervene through Operation Polo in September 1948. The study also evaluates the socio-economic and psychological impact of violence on rural society and its contribution to the growth of resistance movements, including the Telangana armed struggle. It argues that Razakar violence not only exposed the fragility of the Nizam's regime but also played a crucial role in legitimizing Hyderabad's integration into India. Ultimately, the paper highlights how this turbulent phase marked a decisive transition from feudal authoritarianism to democratic transformation.

1. Introduction

The final years of Hyderabad State under the rule of Mir Osman Ali Khan were marked by deep political uncertainty and social unrest. As one of the largest princely states in India, Hyderabad occupied a unique position during the transition from colonial rule to independence. While British paramountcy lapsed in 1947, princely states were given the option to accede to either India or Pakistan. Unlike most rulers who chose integration, the Nizam of Hyderabad sought to maintain independence, a decision that significantly altered the political trajectory of the region.

This period witnessed the emergence of the Razakars, a paramilitary force organized by the Majlis-e-Ittehadul Muslimeen (MIM) under the leadership of Qasim Razvi. Initially projected as a volunteer force intended to protect the sovereignty of Hyderabad, the Razakars soon evolved into a militant organization that played a central role in enforcing the Nizam's authority and suppressing opposition.

The rise of the Razakars must be understood within the broader socio-political context of Hyderabad State. The region was characterized by a deeply entrenched feudal system in which jagirdars and deshmukhs exercised considerable control over land and rural populations. Peasants were subjected to heavy taxation,

forced labour, and social oppression. These conditions led to the emergence of resistance movements, particularly the Telangana armed struggle led by the Communist Party.

As political tensions intensified, the Razakars became increasingly active in suppressing dissent. Reports from the period indicate widespread violence, including attacks on villages, intimidation of political activists, forced conversions, and communal clashes. The actions of the Razakars not only deepened existing social divisions but also contributed to a climate of fear and instability.

The violence associated with the Razakars had far-reaching consequences. It influenced public opinion both within Hyderabad and across India, strengthened resistance movements, and played a crucial role in shaping the Indian government's decision to intervene militarily. Operation Polo, launched in September 1948, ultimately led to the defeat of Hyderabad's forces and the integration of the state into the Indian Union.

This paper seeks to examine the nature and impact of Razakar violence within this complex historical context. It aims to provide a comprehensive analysis of the political, social, and economic factors that contributed to the rise of the Razakars and the consequences of their actions for Hyderabad's transformation.

2. Objectives of the Study

1. To examine the political and social conditions in Hyderabad State leading to the rise of the Razakars.
2. To analyze the organizational structure and ideology of the Razakar movement.
3. To investigate the nature and extent of violence carried out by the Razakars.

5. To evaluate the role of Razakar activities in shaping political developments in Hyderabad.
6. To study the relationship between Razakar violence and the Telangana armed struggle.
7. To analyze how Razakar violence influenced the Indian government's decision to undertake Operation Polo.
8. To assess the long-term socio-political consequences of this period of violence.

3. Review of Literature

The Telangana armed struggle and the political crisis in Hyderabad have been widely studied by historians, yet the specific role of Razakar violence has often been examined within broader narratives.

P. Sundarayya's work provides a detailed account of peasant movements and highlights the oppressive conditions faced by rural populations. He emphasizes the role of feudal exploitation and political repression in shaping resistance.

Barry Pavier's study offers a comprehensive analysis of the Telangana movement, focusing on the dynamics of peasant revolt and the socio-economic factors underlying the conflict.

Bipan Chandra and his collaborators situate the Hyderabad crisis within the larger framework of India's struggle for independence, highlighting the challenges posed by princely states.

Karen Leonard's work provides valuable insights into the socio-economic structure of Hyderabad, particularly the coexistence of modernization and feudalism.

V. P. Menon's account of the integration of princely states offers an administrative perspective on the Hyderabad crisis, including the role of the Razakars.

Despite these contributions, there remains a need for a focused analysis of Razakar violence as a distinct historical phenomenon. This study seeks to fill that gap by examining the issue in detail.

4. Methodology

The study adopts a historical-analytical approach, combining qualitative analysis with the examination of primary and secondary sources.

Primary sources include government reports, archival documents, contemporary newspaper accounts, and memoirs of individuals who witnessed the events. These sources provide firsthand information about the nature and impact of Razakar activities.

Secondary sources include scholarly books, journal articles, and historical studies that provide interpretative frameworks for understanding the period.

Content analysis is used to identify recurring themes such as violence, repression, resistance, and political transformation. Comparative analysis is also employed to examine different perspectives on the role of the Razakars.

5. Results and Discussion

5.1 Rise of the Razakars: The Razakar movement emerged in response to the political uncertainty following India's independence. Led by Qasim Razvi, the organization sought to defend the sovereignty of Hyderabad and support the Nizam's refusal to accede to India.

The movement drew support from sections of the population that feared political and social change. However, its methods soon shifted from defensive mobilization to aggressive enforcement of authority.

- ❖ **Nature of Violence:** Razakar violence took multiple forms, including attacks on villages, looting, destruction of property, and physical assaults on civilians. Peasants and political activists were often targeted, particularly those associated with the Communist movement.
- ❖ The violence also had a communal dimension, contributing to tensions between different religious communities. These developments created a climate of fear and instability across the region.
- ❖ **Impact on Rural Society:** The impact of Razakar violence on rural society was profound. Many villages experienced displacement, economic disruption, and social fragmentation. Agricultural activities were affected, leading to further hardship for already vulnerable populations.
- ❖ At the same time, the violence contributed to the growth of resistance movements. Peasants began to organize more actively, seeking protection and justice.
- ❖ **Political Consequences:** The actions of the Razakars weakened the legitimacy of the Nizam's administration. Reports of violence attracted national and international attention, shaping public opinion against the regime.
- ❖ The Indian government viewed the situation as a threat to national security and stability, leading to the decision to launch Operation Polo.
- ❖ **Operation Polo and Aftermath:** Operation Polo marked the end of Razakar dominance. The rapid military intervention restored order and led to the integration of Hyderabad into the Indian Union. Following integration, efforts were made to address the socio-economic issues that had contributed to the conflict. Land reforms and administrative changes were introduced, laying the foundation for democratic governance.

5.2 Timeline of Escalation: From Political Crisis to Armed Conflict

The rapid deterioration of law and order in Hyderabad State during 1948 can be understood through a sequence of critical events that transformed a political dispute into a full-scale paramilitary crisis. The following timeline illustrates this escalation:

January 1948	MIM Radicalization	Under the leadership of Qasim Razvi, the Majlis-e-Ittehadul Muslimeen adopted an increasingly militant stance, and Razakar recruitment intensified across the state.
22 May 1948	Gangapur Train Attack	Razakar forces attacked the Madras–Bombay Mail, marking a shift from localized violence to actions with interstate implications.
10 August 1948	Bairanpally Massacre	Nearly 100 villagers were killed for resisting Razakar demands, symbolizing the peak of rural terror and coercion.
7 September 1948	Nehru’s Ultimatum	The Government of India publicly declared the need to end lawlessness in Hyderabad to protect civilians, signaling imminent intervention.
13 September 1948	Operation Polo Begins	Indian forces launched a coordinated military campaign, leveraging superior organization and logistics.
17 September 1948	Unconditional Surrender	The Nizam surrendered, leading to the rapid disintegration of the Razakar militia and restoration of order.

This progression reveals how escalating violence, combined with administrative paralysis, compelled decisive military intervention by the Indian Union.

5.3 The Logistics of Collapse: A Material and Chemical Perspective

Beyond political and military factors, the collapse of the Razakar forces can also be understood through the lens of **material capability and logistical sustainability**. The Indian Army’s success in Operation Polo was not only due to strategic planning but also to its reliance on scientifically managed resources and standardized materials. In contrast, the Razakar forces suffered from severe deficiencies in maintaining mechanical and operational infrastructure.

The rise and actions of the Razakars not only exposed the limitations of the Nizam's rule but also accelerated the process of political change. Their violence contributed to the mobilization of resistance movements and influenced the course of national policy.

Ultimately, the integration of Hyderabad into the Indian Union marked the beginning of a new chapter in the region's history. The transition from feudal authority to democratic governance was shaped in part by the experiences of this turbulent period.

The study underscores the importance of examining violence not only as a destructive force but also as a catalyst for political transformation.

This comparison highlights that the outcome of Operation Polo was not solely determined on the battlefield but also in the realm of **scientific logistics and material preparedness**. The Indian Army's ability to maintain fuel quality, communication systems, and mechanical efficiency ensured operational continuity and speed. In contrast, the Razakar forces, lacking institutional support and technical infrastructure, were unable to sustain prolonged resistance.

Thus, the collapse of the Razakar militia can be interpreted not only as a military defeat but also as a failure of logistical systems rooted in the absence of scientific planning and resource management.
